Sub: Industrial Visit Report –Alf Engineering Pvt Ltd

Dear Sir,

The objective of industrial visit was to expose MBA students to the business realities and making them aware about the system, processes and work culture of the manufacturing organization.

Day1(31/05/2023)

Reached Alf Engineering Pvt Ltd on 31st May 2023 at around 10.00 am, completed initial security and administrative formalities. Mr. G S Lahane, HR Manager received us. Mr Parekh sir, Production Manager gave IV participants necessary instructions related to safety precautions and conduct during plant visit. He clarified how the students are going to take a industry tour. The students were toured through 3 main section of the plant which includes press shop, painting shop and assembly.

In press shop, students observed how the steel sheets of various sizes are stocked, moved, measured, gauged and sheared in different sizes as per the specification of auto components. The students also observed the standard operating procedures (SOP) of shearing metal sheets. Mr Parekh sir explained the layout of press section. Students observed the press processes, understand how the jigs, fixtures and dies functions and setting of the M/c. He further explained how the non conformities are disposed off by the concerned responsible function. Students also observed the robotic welding machines and store room wherein different components required for chassis assembly are stored.

During painting shop visit, students observed the cleansing, degreasing process used to cleanse the chassis from dirt, oils and greases to get good paint film on chassis surfaces.

Students finally visited Chassis assembly shop. It included 3 departments viz store room/material receiving section, sub assembly and main assembly. Sub assembly and main assembly are mainly inhouse with robotic welding machines. Students observed the quality assurance operations during assembly of chassis. The students get exposed to concept of Total Productivity Management (TPM), 5 S housekeeping and daily production performance dash board. Mr Tipare Sir Plant Head addressed the students. Mr Sandip Rahane, Mr. Kote sir and Mr Parekh sir facilitated and coordinated the visit.

HR and Finance students got an opportunity to have an interaction with HR and finance people. Mr G S Lahane sir told that they have a requirement of two MBA HR students for their newly established plant at Khed. They personally spoke to HR students and assure us that whenever hiring process start, they will give institute student's an opportunity for interview. Finally, Students were offered tea and biscuits

by the company. Visit continued for around two and half hours. IV group photos were taken. Dr R B Gawali and Dr, N S Jondhale gave vote of thanks. Industrial visit concluded at around 12.30 pm. 63 students and 5 faculty benefited from industrial visit.

In brief, Alf Engineering was manufacturing Chassis required for Mahindra and Mahindra for it's different vehicles. The complete process of chassis manufacturing which starts from pressed components to final assembly is carried out at the visited industrial unit.

Reached at Nagaon beach, Alibag at around 7.00 pm in the evening, faculty divided into different teams discharged the responsibilities of making separate staying arrangement for girls and boys. Finally everybody took dinner.

Day 2(01/06/2023)

In the morning of 1st June 2023, faculty and students enjoyed the beach view and played water sports upto 9.30 am. After that students took breakfast and left for Kankeshwar temple at around 12.00 noon.

We reached at Kankeshwar temple at around 1.30 pm. It was a Mahadeo Temple which is situated at hill top which is around 5000 feets from ground level which took around 700 steps. On the way students took snacks and finally at around 10.30 pm, we reached at Hotel Purohit (Aakash Hotel) for Dinner. Students finished their dinner at around 12.00 pm.


Day3(02/06/2023)
