Policy Statement/Objective:

To establish guidelines for providing financial assistance, including loans and reimbursements, to employees of organization.

Scope: This policy applies to all employees of the Institute.

Definitions:

Financial Assistance: Any form of direct, insured, or guaranteed loan, grant, or other direct or indirect assistance provided by the employer to its employees.

TA & DA: Travel Allowance and Daily Allowance.

FDP: Faculty Development Program. UGC: University Grants Commission.

Scopus / Web of Science / ABDC: Academic databases.

Responsibilities:

The authority is responsible for discretion regarding reimbursements and loans. Employees are responsible for adhering to the policy guidelines.

Procedures/Guidelines:

Policy for Teaching Staff:

- 1. 100% reimbursement of registration fees, including TA & DA, for participating in Seminars, Conferences, Workshops, Professional Body Membership and FDP.
- 2. Reimbursement limit of up to Rs.15,000 per year for National and International events in India.
- 3. Discretionary reimbursement policy for events outside India.
- 4. 100% reimbursement for publishing papers in specified journals (one in UGC-listed journals and one in Scopus / Web of Science / ABDC). Maximum limit of Rs. 7,000 per year.

Policy for Non-Teaching Staff:

- 1. 100% reimbursement of registration fees for Seminars, Workshops, Conferences, and FDP.
- 2. Reimbursement limit of Rs.10,000 per year for National and International events in India.

Compliance: Compliance with this policy will be monitored by HOI
